## Take the challenge!

### Entry Requirements

#### UTME

- Current JAMB approved cut-off mark
- The required UTME subjects are English language, Mathematics, Economics and any other subject in Arts or Social Sciences.

#### Direct Entry

To be eligible, an applicant is required to have one of the following qualifications:

- Two advanced level credits in Arts, Social Science or Science subjects.
- International Baccalaureate Diploma (IB) in relevant subjects.
- NCE with merit in a relevant discipline
- An OND/HND credit level in a relevant discipline.
- ICAN-ATS 3 certificate

#### 'O' Level

Credit level passes in at least five subjects at 'O' level in a nationally recognized examination Mathematics, English and Economics inclusive and any two of Commerce, Accounting, Business Studies, Marketing, History, English Literature, Government, Civic Education and CRS/IRS).
