The M.Sc. economics programme provides rigorous training on core areas of economics that will equip students for job openings in government, international organizations, economic institutions, research firms and academics.

The programme aims to provide a solid foundation of knowledge and skills needed to understand and contribute to the development of Nigeria and the global community through a thorough understanding of the workings of an economy and the constructive use of that knowledge in various settings.

The course will emphasize developing critical thinking and deductive and inductive reasoning skills. Graduates will be able to abstract, using simplified models that identify the essence of a problem, to analyze and reason – both inductively and deductively, to marshal evidence, assimilate structure and analyze quantitative and qualitative data.

The aim is to enable graduates to communicate results concisely and think of the limits of their analyses in a broader socio-economic context. With or without a strong background in economics, they can draw economic policy inferences and recognize the potential constraints to their implementation.

Lastly, with access to some data science and ethics courses, they will become competent professionals with solid ethical traits.

Entry Requirements

- Candidates seeking entry to the M.Sc. programme in Economics should hold a bachelor's degree (Second Class Honours or above) in Economics and related disciplines.
- Candidates will be required to satisfy the Department in a selection process through an entrance examination and interview.
- Candidates must have five credit passes including English and Mathematics at the O'level.
- Candidates from other related disciplines will be offered provisional admission and are expected to undergo an online bridge programme for 2 months (July-August) and must meet 80% online class attendance.
- A confirmation of the provisional admission is subject to meeting a minimum grade of 50% in each of the courses.

Application Period: January - August

Entrance Exam Date: February - August

Annual Start Date: September

Online Bridge Programme: July-August (Compulsory for candidates from other related disciplines)

Application Fee: ₦10,000 to be paid after filling the application form online@apply.pau.edu.ng
