Schools of the University

Lagos Business School

Lagos Business School (LBS) is the oldest unit of Pan-Atlantic University. It shares a campus with the Enterprise Development Centre of the university in Lagos.

The school offers several MBA programmes and also provides experienced professional managers with high-quality general management education relevant to the Nigerian business environment. Besides being accredited by the National Universities Commission, LBS has also obtained accreditation from AACSB and AMBA, Association of African Business Schools (AABS), and ISO 9001:2015 certification

LBS offers many open-enrolment seminars on essential issues in business for corporate leaders and managers. Customised incompany seminars are also arranged for companies who need to train large groups of staff in a particular area.

Executive education at LBS has a strong practical orientation, drawing from the experience of the faculty and participants. The system of teaching privileges the case-study method and group-work approaches to learning.

School of Media and Communication

Pan-Atlantic University instituted the School of Media and Communication to recognise the crucial role of the media and entertainment industries in shaping societal values and cultural life. Equally important is the growing contribution of the creative industries to the Nigerian economy.

SMC seeks to train professionals who will uphold the highest intellectual, ethical, and professional values that promote creativity, critical knowledge, technical preferences, social responsibility, and the spirit of the enterprise.

The school offers B.Sc. programmes in Mass Communication and Information Science and Media Studies, full-time and part-time M.Sc. programmes, and a PhD in Media and Communication. SMC also offers seminars, workshops, and certificate programmes for professionals.

School of Management and Social Sciences

The School of Management and Social Sciences aims to deliver economic and business education relevant to the rapidly evolving global environment.

The School of Management and Social Sciences currently runs B.Sc. programmes in Accounting, Business Administration, Economics and Finance, M.Sc. in Economics and a doctoral programme in Management.

School of Science and Technology

The School of Science and Technology aims at "forming competent and socially responsible science and engineering professionals committed to the promotion of the common good of society and the advancement of the scientific and engineering profession.

"To achieve this mission, the school seeks to:

- · Provide practice-based, student-centered, and industry-relevant programmes that address technical expertise, industrial management, and ethical responsibility.

Units of the University

Enterprise Development Centre

The Enterprise Development Centre's mission is to provide business development and support services to small and medium enterprises (SMEs) in Nigeria. It provides capacity-building programmes and various services such as business advisory, mentoring, networking meetings, access to market and information, experts-in-residence, retreats, and implementation of organisational plans. Many top organisations - Nigerian and International - see EDC as their partner of choice in their efforts to develop the SME sector (and talents) in Nigeria.

EDC is leading efforts in building a vibrant SME ecosystem in Nigeria and beyond through its work with Aspen Network of Development Entrepreneurs (ANDE) and the Global Entrepreneurship Network (GEN), amongst others. Through the support of the MasterCard Foundation, EDC revamped the SME Toolkit Nigeria Portal with exciting tools, articles, videos, and e-learning features.

Institute of Humanities

The Institute of Humanities is an academic service unit of the University. Given the importance that Pan-Atlantic University gives to providing an all-round education for all students, all undergraduate programmes in the University contain at least 40 credit hours devoted to providing a broad liberal education. Having a unit dedicated to organising and providing these courses guarantees that this aspect of our students' education is given the attention and priority it deserves.

The Institute's staff members face the same demand for research work as those working in other schools of the University and, likewise, have the same opportunities for promotion and recognition.

In addition, this Institute is projected to become the seed of a future School of Humanities.



Yemisi Shyllon Museum of Art (YSMA)

The University set up the Yemisi Shyllon Museum of Art (YSMA) thanks to financial support and a generous grant of over 1,000 artworks by Prince Yemisi Adedoyin Shyllon. It is a teaching museum that engages and serves diverse audiences in the University and larger community through exhibitions and educational programmes, helping them learn about art through art.

Currently, the YSMA holds a permanent collection of more than 1,200 artworks by Nigerian artists, ranging from the precolonial period to the present age.



Opus Dei & the University

University Campuses

Main Campus

The University's main campus occupies a 100-hectare piece of land in Ibeju-Lekki, Lagos State. On this campus are the University Administration, the School of Media and Communication, the School of Management and Social Sciences, the School of Science and Technology, the Institute of Humanities, and the Yemisi Shyllon Museum of Art.



Lekki Campus

Our Lekki campus occupies an area of 10 hectares and is located near Ajah, Lagos. This campus is the site of Lagos Business School and the Enterprise Development Centre.

From the Vice-Chancellor

The 2023/2024 academic year was a year of growth marked with significant milestones in our commitment to building responsible leaders. It is my pleasure to share some of the year's notable milestones and highlights, each a testament to the commitment and hard work of our faculty, staff, and students.

Academic Excellence and Programme Expansion

In alignment with the Teaching and Learning pillar of our strategic plan, we remained steadfast in delivering an integrated and inclusive educational experience for students by securing approval from the National Universities Commission (NUC) to launch four new undergraduate programmes: B.Sc. Software Engineering, B.Sc. Data Science, B.Sc. Film and Multimedia Studies, and B.Eng. Mechatronics Engineering. These additions underscore our dedication to offering relevant and forward-thinking curricula that prepare our students for success.

The NUC also approved the commencement of a Master of Science in Management (MiM) programme, which will be jointly run by Lagos Business School and the School of Management and Social Sciences. The programme aims to bridge the gap between the growing need for leadership and managerial skills in today's dynamic business environment and the existing skill set of young graduates and entry-level managers.

Knowledge Exchange and Fostering Societal Impact

As part of our commitment to advancing knowledge and fostering a vibrant intellectual community, this year saw Pan-Atlantic University host a series of landmark events, each creating unique platforms for exchange and growth. Lagos Business School took a prominent lead with the



"Fireside Chats," an initiative that connects global leaders with students, staff, faculty, and alumni by enabling insightful dialogues and the sharing of invaluable experiences.

Furthering our dedication to critical academic discourse, the Institute of Humanities organised the International Conference on Natural Law and Human Dignity in August 2024. This conference gathered scholars and professionals from around the world, sparking significant discussions at the intersection of ethics, law, and human rights—an area of global relevance. In a significant development, PAU hosted the inaugural West Africa Hub Convening of the Education Collaborative in March 2024, bringing together 33 higher educational institutions with over 105 participants from 11 countries.

The event presented a unique opportunity for stakeholders in higher education institutions to champion excellence in research, and leadership, enhancing graduate employability outcomes across West Africa.

Celebrating Student Creativity and Innovation

Our undergraduate students continued to distinguish themselves with remarkable achievements, reflecting the University's commitment to experiential learning. During the School of Science and Technology (SST) Week in June, engineering students displayed their robotics skills in a Motobot Competition.

From the Vice-Chancellor

We are also proud of the success achieved by our student team, "The Blazer," as they secured a remarkable second-place finish in the Africa Rover Competition. This prestigious competition challenges students to design and build a Mars rover prototype, a small, mobile robot capable of wireless control and self-powering.

We also celebrated the creative ambitions of our students through the inaugural Pan-Atlantic University Student Film Festival (PAUSFF), organised by the School of Media and Communication in June 2024.

The festival featured workshops and screenings, culminating in an awards ceremony that highlighted the extraordinary talents of our student filmmakers. It was an honour to welcome celebrated filmmakers and scholars, whose participation enriched the experience for our students and attendees alike. These initiatives are emblematic of the innovative and research-oriented culture at Pan-Atlantic University.

Driving Sustainability and Innovation in Education Excellence

This year, we made significant strides in our sustainability agenda, particularly with our initiative towards creating a Styrofoam-free campus. This forms part of our larger efforts to reduce waste and promote eco-friendly practices.

Our focus on sustainability was recognised internationally as the university was featured in Times Higher Education's University Impact Rankings for Sustainable Development Goal 4: Quality Education.

Pan-Atlantic University was listed among the Top 10 Universities in Africa to Study Blockchain by Emurgo Africa, further demonstrating our focus on innovative technologies.

In addition, our Accounting Programme earned seven exemptions for ACCA accreditation and secured a 5-year reaccreditation, further establishing our reputation for excellence in accounting education.

Community Engagement and Social Impact

Pan-Atlantic University strengthened its ties with the Ibeju-Lekki community through various initiatives, most notably the UTME Quiz-A-Thon competition. This competition, organised in collaboration with the Ibeju-Lekki Local Government, rewarded the academic excellence of local students, furthering our mission to promote academic success and innovation in our local community.

Our partnerships extend beyond academia. In May 2024, we signed a Memorandum of Understanding (MoU) with Sahara Power Group to drive enhanced human capital in the power sector. This collaboration aims to build capacity through shared knowledge, experiences, and exchange programmes between Sahara and PAU to make the power sector innovative, adaptable, and sustainable across the value chain.

Pan-Atlantic University's Community Relations: Fostering Educational Advancement and Community Development

Introduction

In line with its Corporate Social Responsibility (CSR) objectives, Pan-Atlantic University (PAU) embarked on a transformative journey of community engagement and development in collaboration with the Ibeju-Lekki Local Government. This report highlights the significant initiatives and achievements of Pan-Atlantic University's Community Relations unit, which has played a pivotal role in enhancing educational opportunities and fostering strong community relationships.







Science Tutorial Programme

Pan-Atlantic University, in partnership with the Ibeju-Lekki Local Government, continued the Science Tutorial Programme for senior secondary school students within the Ibeju-Lekki community. This initiative aimed to equip students with the knowledge and skills required to excel in their academics, particularly in preparing for the Joint Admissions and Matriculation Board (JAMB) examinations. The goal was to secure scholarship placements within PAU and other institutions.

This programme not only demonstrated Pan-Atlantic University's commitment to education but also served as a stepping stone for the academic future of numerous students. It underlines Pan-Atlantic University's dedication to nurturing talent and empowering the youth, aligning with its mission to create transformational leaders.

ELEVATE THEM (Stream 2): STEM Training Programme

In a ground-breaking collaboration with the Lagos State Research Innovative Council (LASRIC), Pan-Atlantic University's School of Science and Technology (SST) initiated the "ELEVATE THEM" programme.

This programme focuses on training young minds in Science, Technology, Engineering, and Mathematics (STEM). The partnership with LASRIC strengthened the educational landscape in Lagos State, contributing to the overall advancement of STEM education.

This collaboration showcased Pan-Atlantic University's commitment to fostering innovation, scientific inquiry, and technological advancements within the community. The "ELEVATE THEM" programme has undoubtedly had a positive impact on both the local community and the broader Lagos State.

Quiz Competition

A quiz competition tagged PAU Quiz-A-Thon was launched in December 2023, with the aim of supporting students in secondary schools in the Ibeju-Lekki Local Government Area in Commerce, Economics, Government, Mathematics, and English Language for the Unified Tertiary Matriculation Examination (UTME).



Six secondary schools from Ibeju-Lekki Local Government participated, each sending ten of their top five performers stood a chance to win sponsorship for the Unified Tertiary Matriculation Examination and a scholarship to PAU upon meeting the entry requirements for Pan-Atlantic University.





Scholarship Offers

Four out of the students who took part in the PAU Science tutorial and Quiz competition received scholarships to study at Pan-Atlantic University.

Sustainability Report

A. Year-on-Year Reduction in Per Capita Electricity Consumption

Introduction:

The primary objective for the year was to achieve a 5% year-on-year (YOY) reduction in per capita electricity consumption by the 4th quarter. This goal was set to enhance energy efficiency across campus and contribute to our sustainability efforts.

Summary of Results:

Throughout the year, targeted efforts were made to optimize electricity usage. The initiative, which began at the start of the last session, involved monthly and quarterly monitoring, using a year-on-year comparison as the benchmark.

The results for the 1st and 2nd quarters of this year were as follows:

- · Q1: 14.06% decrease
- · Q2: 28.12% decrease

Overall Reduction to Date: 15.37% decrease

Analysis:

The significant reduction in electricity consumption was achieved through a strategic combination of initiatives, including optimizing operational hours and implementing energy-saving practices.

Additionally, the increased presence of staff and students on campus contributed to a more efficient use of energy per capita. The results, particularly in Q2, highlight the effectiveness of these strategies in achieving substantial reductions.

Conclusion:

While the original target was a 5% reduction, the actual achievement has far surpassed expectations, with an overall reduction of 15.37% in per capita electricity consumption. This impressive outcome reflects the collective commitment of the entire campus community to energy conservation and sets a strong precedent for continued efforts in sustainability.



B. Horticulture Unit Sustainability Report

Introduction

The sustainability goals for the Horticulture unit were aimed at increasing forest cover, improving landscape aesthetics, and contributing to environmental conservation.

Sustainability Initiatives and Achievements

Tree Planting

In the year 2024, a total of 1,252 trees of various species were planted. This is in addition to the 1,000 trees that were planted in the previous year, 2023. As a result, the total number of trees on the university premises is now 2,252, representing a 125.2% increase in the tree population.

PAU Services 21

Forest Cover

Despite expansion pressures, forest cover remains at 515,047.25 sqm. All physical expansion requests were intentionally accommodated within the currently used space hence safeguarding our forest – (We are safeguarding a quantum of 257,500kg of CO2 per year)

Nursery Development

To ensure the continuation of tree planting initiatives and mitigate the risk of extinction, we engaged in the expansion of the nursery and introduced the exotic tree (Norfolk tree).

Within the year in review, we propagated 3100 new seedlings out of which 100 are Norfolk trees, all reflecting a significant 777% increase in nursery capacity. (new nursery capacity is 3100/399)

Carbon Sequestration

The increased tree planting has contributed to enhanced carbon absorption by the university's forest areas.

The 1,252 newly planted trees are estimated to absorb an average of 27,540 kg of CO2 annually, contributing to improved environmental health.

Lawn Development for Aesthetics

A total of 335,477.99 sqm of lawns were improved across the campus, with regular maintenance ensuring a lush, green appearance.

External horticulturists collaborated to improve the University's entrance landscape.

Conclusion and Future Plans

The unit faces climate variability but plans to expand tree planting, improve irrigation systems, and start a horticulture farm to supply 5% of the cafeteria's vegetables.

C. Sustainability Efforts of the Maintenance Unit

Objective:

To continue the reduction of the carbon footprint of the University through:

- Increase in energy generated from Natural Gas from 61% to 85% by Q4 and consequent reduction in diesel consumption.
- To achieve at least 7% of energy generation from Solar power by the end of Q3

Result:

83% of power generation from Natural Gas plant has been achieved. This is a 22% reduction in diesel consumption from 2023 basis. The implementation of solar plant has not been completed.

Analysis:

The reduction in diesel consumption was achieved by upgrading of the Natural Gas power plant and optimization of the power plant by the deployment of a synchronization panel for efficient power evacuation.

The unit is making progress in its pursuit of greener energy sources. It is currently focused on finalizing the construction of a solar power plant and establishing partnerships with the School of Science and Technology to explore energy generation from human and kitchen waste (Biogas).

Student Affairs Update

1. Scholarships

During the 2023/2024 academic session, a total of 351 students benefited from the university's scholarship programme as follows:

- 25% scholarship: 11 students

- 50% scholarship: 24 students

- 75% scholarship: 36 students

- 98% scholarship: 103 students

Total: 174 students

Furthermore, the university provides 50% discount as financial assistance to students whose parents are university staff. In the 2023/2024 academic session, 19 students received this discount.

In line with its commitment to community collaboration, the university awards a 98% scholarship annually to indigenes of the Ibeju-Lekki community who gain admission to PAU. In the 2023-2024 academic session, 3 students benefited from this scholarship.

Lastly, the university offers discounts to siblings from the same family who are enrolled simultaneously. The breakdown of sibling discounts awarded in the 2023/2024 academic session is as follows:

- 10% sibling discount: 158 students

- 50% sibling discount: 10 students

- 98% sibling discount: 0 students


Food Tracking, Simplified: PAU Student Innovation

As part of their hands-on experience under the Student Industrial Work Experience Scheme (SIWES) at Pan-Atlantic University, a team from the School of Science and Technology developed a cutting-edge food tracking and ordering system. Comprising Stanley Igwe, Pius Ndukwu, and Mohammed Al-Hameen, this team designed an innovative solution to streamline food tracking and make it accessible to the university community.

The system uses a custom weight sensor and a microcontroller to accurately track food weight and calculate available food quantity. In addition to this, a web app was created to

display a real-time menu, allowing users to make informed purchasing decisions.

The students collaborated with mentors from different fields, including software engineering, mechanical engineering, and electrical engineering. This project showcased the ingenuity and collaborative spirit within the PAU community.




Pan-Atlantic University Student Creates Innovative VR Solution for Stroke Rehabilitation

Oluwanifemi Oyewole, a final year Computer Science student at Pan-Atlantic University, has developed a VR-based intervention for poststroke upper-limb rehabilitation. The simulation-based approach includes functional tasks, bilateral coordination, and range-of-motion exercises.

The VR-based intervention is effective and promising for stroke patients and provides insight for future innovation.

PAU Students Develop 'Trailblazer' First Mars Rover In Nigeria, Africa



Students at Pan Atlantic University (PAU) in Nigeria have created the first Mars rover prototype in Africa. The rover, named "Trailblazer," was designed and built by a team of 14 students from the university's School of Science and Technology.

The team members are Afolabi Ibukunoluwa, Samuel Oyefusi, Udenkwo David, Atunwa Oluwamurewa, Adediran Adedamola, Ntia-James Andikan, Apampa Muizah, Ajayi Samuel, Mohammed Al-Hameen, Salami Marvellous, Usim David, and Atuorah Michael.

The rover features a rocker-bogie suspension system, three cameras, a robotic scoop arm, a mini rocket for payload launches, a solar-powered docking station, and wireless control. It also incorporates artificial intelligence for mineral and image analysis, and a LiDAR scanner, magnetometer, and environmental sensors for real-time data collection. The rover is expected to provide valuable insights into planetary exploration.

Innovation on Wheels: A Look at the MotoBot Competition | Pan-Atlantic University Experience

This initiative, centered around experiential learning, provided students a unique extracurricular platform to apply classroom knowledge in real-world scenarios.

The primary goal of the MotoBot Competition was to bridge the gap between theoretical knowledge and practical application, allowing students to bring their academic learning to life. It encouraged innovation, collaboration, and skill development, helping students transform their classroom experiences into tangible projects.

This initiative fostered creativity and hands-on experience, strengthening the educational journey for students across disciplines.

3. Community Service Project

The Community Service Project (CSP) is an initiative of Pan-Atlantic University whose main aim is to foster in its students a sense of service and responsibility towards others in the community. This is in keeping with its mission to form competent and committed professionals and encourage them to serve with personal initiative and social responsibility, the community in which they work, thereby helping to build a better society in Nigeria and Africa at large. The Community Service Project has been positively impacting the University's surrounding communities since November 2016.

Beach Clean-up Exercise

The Community Service Project of Pan-Atlantic University organised a Beach Clean-Up on November 25th, 2023, with 17 volunteers from CSP. The aim was to clean Eleko Community Beach, foster team spirit, and promote environmental responsibility. After dividing into groups and cleaning different areas, we disposed of the collected waste and spent time bonding through conversations, games, and a shared meal. It was a successful event,

promoting both community engagement and environmental conservation.

Maiden JAMB Quiz

The JAMB Maiden Quiz, held in December 2023, marked a significant milestone for the Community Service Project of Pan-Atlantic University. 3. Inaugural CSP Inter-House Sports Event


Maiden Reunion

CV Review/ CV Writing Clinic

The Careers Office conducted a comprehensive CV review and writing clinic to enhance students' employability. The primary goal was to ensure that students' CVs were professional, well-structured, and effectively showcased their skills and experiences. The specific objectives included improving the quality of student CVs, providing personalized feedback, imparting knowledge on crafting compelling CVs, and increasing students'

chances of securing internships and job placements after graduation. During the review period, approximately 106 CVs were reviewed in response to requests via the career services portal.

Additionally, an online CV writing clinic took place on March 6th and 7th, 2024 for compulsory and voluntary internship students. The event saw the participation of 198 out of 446 compulsory internship students and 177 out of 852 voluntary internship students.





CAPSI-Mastercard Methodology Workshop, - March 2024



Enterprise Development Centre (EDC)

Introduction

From dynamic collaborations/partnerships, and bespoke services to impactful community projects and cutting-edge research, the Enterprise Development Centre (EDC) continues to be a thriving hub where ideas flourish and small business leaders are supported to thrive. EDC has evolved into a cornerstone of entrepreneurship education, training, and consultancy. This year's annual report encapsulates the spirit of enterprise that permeates our operations.

The centre signifies a commitment to adaptability and a continuous pursuit of excellence hence the intentionality in going beyond borders and taking more seriously issues around diversity, equity and inclusion.

Strategic Alliances

Recognizing the place of strategic alliances and partnerships in fostering a collaborative ecosystem that enhances innovation, resource sharing, and reach, EDC has continued to leverage diverse partners, to enable the centre to offer comprehensive support services, and a broader network of industry connections.





Empowering Young female Entrepreneurs with State Governments

Through the Transforming Nigerian Youths program, a partnership with Mastercard Foundation which seeks to provide business/entrepreneurial management skills and business support services to young female entrepreneurs, EDC is working with the governments of Delta, Enugu, Akwa Ibom, Osun, Katsina, Benue to deliver training, business support services and in some states grant support to the participants. EDC is also working with the National Directorate of Employment (NDE) and private organizations in this regard.

Advancing Circularity with Circular Business Platform

Increasingly, embracing circularity has become crucial for sustainability, economic resilience and growth of SMEs. EDC has been at the forefront of ensuring sustainability in small businesses. In partnership with the Circular Business Platform, Enterprise Development Centre launched initiatives aimed at advancing the practice of circularity by SMEs. Part of the initiative is the Circular Oasis Mentoring Series, which is a six-week transformative mentorship program



designed for aspiring youth leaders, circular entrepreneurs, and advocates. The program focuses on circular economy principles, business innovation, career development, and leadership excellence. Following the six-week training, participants will engage in mentorship activities for an additional three months.

Enhancing AI Capacity of Nigerian SMEs with Global AI Council Nigeria

Artificial intelligence is critical to fostering innovation and growth in SMEs. Despite the numerous advantages, a lot of entrepreneurs are yet to understand how to maximise the numerous benefits. EDC has launched a partnership with the Global Al Council in Nigeria, a leading organization dedicated to advancing artificial intelligence (Al) knowledge, education, and application across the country.

The AI Readiness of Nigerian SMEs Study which is part of the partnership details will serve as the foundation for developing capacity building programs for SMEs to leverage AI in their businesses, ensuring that it addresses the specific needs and challenges of Nigerian SMEs.

Al Readiness of Nigerian SMEs Survey with eTranzact

The adoption of artificial intelligence (AI) technologies among Nigerian SMEs remains low due to various barriers such as lack of awareness, limited resources, and technical expertise. To address this gap, Enterprise Development Centre (EDC) and eTranzact partnered to conduct an AI Readiness for SMEs Study in Nigeria. The study highlights the current level of awareness and knowledge gaps that need to be addressed through education and training programs. Outcomes of the study will significantly enhance AI readiness, promote educational initiatives, and drive innovation within Nigeria's entrepreneurial ecosystem.

Promoting Risk Management Knowledge with IEI

Risk management is a crucial process for SMEs as they operate with limited resources and are vulnerable to risks compared to large firms. EDC is excited to announce a partnership with International Energy Insurance (IEI). This partnership involves curriculum and case study development and provision of training to small business owners and managers on Risk Management and Insurance. IEI is also sponsoring the rebranding of the recording studio for production of knowledge resources for SMEs.

Beyond Borders

EDC is committed to fostering global entrepreneurship. By extending our reach and resources across international boundaries, the centre aims to empower entrepreneurs with the tools, networks, and opportunities needed to thrive in a globally interconnected marketplace. Some of our efforts are highlighted.

Creative Business Cup

Towards providing a platform for young people in the creative sector to showcase their ideas, EDC in partnership with Mastercard Foundation and Global Entrepreneurship Network (GEN) Nigeria organises the Creative Business Cup (CBC) annual competition. This competition serves as a pinnacle event for entrepreneurs and aspiring entrepreneurs alike across various creative domains, including fashion, design, arts and craft, leatherworks, photography, gaming, music, film, and renewable energy. Despite the abundant potential within these industries, many creative entrepreneurs lack the essential business acumen to propel their concepts forward. The focus of the CBC is to empower creative entrepreneurs by facilitating connections with investors and global markets and enhancing their capacity for innovation.

7,272 entries were received for the Creative Business Cup. Partnerships were forged with creative institutions and hubs in Abuja, Enugu, Kano, Delta, Oyo State, and Lagos State to spread awareness about the competitions. 200 outstanding applications were selected for the Creative Business Cup. After the bootcamp, each participant had the opportunity to present an online pitch to a panel of judges. The winner represents Nigeria at the global competition.

Agrohack Competition

To support entrepreneurs in the agriculture sector, showcase their ideas and contribute to innovations in the sector, EDC in partnership with the Global Entrepreneurship Network Nigeria and Mastercard Foundation, organises the AgroHack Challenge. The Agrohack Challenge is a dynamic and innovative competition designed to inspire

and empower individuals, startups, and organizations to develop groundbreaking solutions for the agricultural sector. This challenge seeks to address critical issues such as food security, sustainable farming practices, and agricultural technology advancements by fostering a collaborative environment where participants can showcase their creativity and technical expertise.

Participants in the Agrohack Challenge are typically tasked with creating innovative projects or prototypes that leverage technology, data, and new methodologies to solve pressing agricultural problems. These may include improving crop yields, reducing waste, enhancing supply chain efficiency, or developing sustainable farming practices. The challenge has seen 100 teams (each with a team lead and member) making 200 participants for the AgroHack Challenge. These selected participants were invited to a 5-day hybrid bootcamp.

Platform for Growth

Beyond capacity building, consulting, mentoring, EDC also provides access to market, access to funding and access to resources to entrepreneurs in the ecosystem. Under the year under review, alumni members had the opportunity to pitch and showcase their products and services.



Global Entrepreneurship Congress (GEC+)

In supporting entrepreneurs and exposing them to global markets, over 40 entrepreneurs from Nigeria not only showcased their products and services but also made business connections at the GEC+ Africa event in Cape Town, South Africa. GEC+ is a regional extension of Global Entrepreneurship Congress. It's a gathering of founders and leaders from more than 43 African nations committed to advancing entrepreneurial activity throughout their own countries. GEC Africa feature various components designed to engage and support entrepreneurs like Conferences, Pitch competition, Exhibition areas, training and Workshops, and policy dialogues.

Various sessions were held, including bootcamps, pitch competitions, research discussions, and seminars focused on women's entrepreneurship and seed capital.

Notable sessions featured:

- "Advancing a Social Entrepreneurship Agenda for Growth and Job Creation in Africa," with Dr. Nneka Okekearu, Director of the Enterprise Development Centre.
- Mr. Charles Odii, Director-General of SMEDAN, speaking on "Providing Financial and Non-Financial Support to Stimulate Innovation and Invention."
- Dr. Olawale Anifowose, Director of Programs and Partnerships at the Enterprise Development Centre, also contributed to "Building Effective Capacity-Building Programs for SMEs."

GEC+ Africa 2024 also featured the Nigeria Village, a dedicated platform for Nigerian entrepreneurs to showcase their products to over 1000 delegates which held on the 13th





and 14th of March 2024 in collaboration with SMEDAN, Bank of Industry Nigeria, Providus Bank, and GEN Nigeria. A total of 40 businesses exhibited even as 35 other businesses who were unable to attend in person had their products showcased at the village, facilitated by the GEN, SMEDAN, and Providus Bank. A brochure highlighting the offerings and contact details of the entrepreneurs was crafted, facilitating networking and partnerships. The Nigerian entrepreneurs generated over 150,000 Rands in total revenue, and multiple partnerships were formed between them and other delegates.

The Nigeria night hosted by GEN Nigeria held on the sidelines of GEC+ at the Southern Sun Cullinan Hotel Cape Town in collaboration with Enterprise Development Centre, SMEDAN, Tripoint Travels and Bank of Industry Nigeria who supported the event through funding, showcased Nigeria's innovation and entrepreneurial vigor to an international audience.

PAU Demo Day and Undergraduate Programmme

The journey to entrepreneurship can start at any age. For EDC, it is never too young to start entrepreneurship. Our work at the undergraduate level implies that the centre is able to expose the students to entrepreneurial opportunities. PAU Demo Day is the formal presentation of the solutions developed during the academic session. Student groups showcase their ideas to investors, gaining exposure, facilitating connections with potential partners, and unlocking additional resources. This event significantly enhances the undergraduates' opportunities for future entrepreneurial success.

The PAU Undergraduate Programme offers a course on Entrepreneurship designed to provide students with a practical understanding of entrepreneurial principles. In addition to grasping the importance of entrepreneurship in society and its role in addressing everyday challenges, students will learn about the entrepreneurial process and how they can engage in it in their future careers.

Students are organized into groups of 8-11 members from different departments, tasked with developing a marketable solution. Each group is paired with a mentor who helps them refine their ideas, culminating in presentations at the "PAU Demo Day." The top five solutions receive two months of intensive support, with the top three awarded seed funding.

MTN Foundation Y'ellopreneur Programmme for Women Phase 2

EDC works with partners to provide support services and opportunities for female entrepreneurs to thrive. The MTN Y'ellopreneur Initiative seeks to contribute to the reduction in women unemployment and advance women development in 'Entrepreneurship' through capacity building and access to capital through loans, grants, and advisory support services for long term business sustainability.

The initiative targets Female Entrepreneurs across the country who display passion and commitment to self-employment and run an existing business of two years and above in the areas of; circular economy, manufacturing, processing, agriculture, ICT/digital services, waste management, etc. The focus is on businesses that source their raw materials locally.

MTN Nigeria Foundation launched a pilot phase of the Y'ellopreneur Initiative in 2022 in partnership with EDC as the training partner. In Phase One, 4,711 Female Entrepreneurs were trained in the fundamentals of business Management & Development. This training empowered them to vie for the opportunity to receive up to N2 Million as equipment loan/grants to grow their businesses. Equipment loans of over N94 Million were disbursed to 50 female entrepreneurs. Upon full repayment of the loan, our Y'ellopreneurs will receive 25% of the loan value as grants.







The Phase 2 activities of the MTN Yellopreneur Initiative include:

- 1. Entrepreneurial skills training for 1,000 female entrepreneurs.
- 2. Development and presentation of bankable business plans.
- 3. Equipment loan support of up to N3 million each to 150 female entrepreneurs.
- 4. Business advisory support services.
- 5. Seamless loan repayment processes to ensure project sustainability.

Access to Market Events

EDC continues to embark on access to market initiatives aimed at empowering entrepreneurs to successfully penetrate and thrive in markets. Access to market events were held across 12 states of the federation for young female entrepreneurs. The events featured exhibitions, experience-sharing sessions and masterclasses.

Enterprise Stories on Air

In a bid to leverage electronic media in reaching more entrepreneurs, EDC in partnership with Providus Bank hosts a radio programme every Tuesday at 3pm on Inspiration 92.3fm Lagos. The 30-minute enterprise program provides a platform for sharing success stories of everyday entrepreneurs in Nigeria.

The live programme which listeners can call-in also features business consultants and subject matter experts who provide expert analysis and advisory sessions on air. The expert analysis highlights the critical success factors or decisions that could help small businesses. Entrepreneurs also use the platform to showcase their products and services for possible patronage and partnerships.

The program is streamed live on www.ifm923.com.

New Programmes

Business Owner Strategy Session

EDC constantly seeks to design programmes aimed at assisting SME founders in navigating the evolving business requirement. One of the latest programmes is the Business Owners Strategy Session (BOSS) – EDC launched on the 18th of September 2023 with the 1st cohort of 20 participants.

The Business Owners Strategy Session (BOSS) is a specialized 5-month certificate programme designed for medium-large sized business owners seeking to scale. It provides a comprehensive strategic framework and hands-on guidance to help participants drive growth, improve processes, and achieve long-term business sustainability.

The program aims to:

- 1. Equip participants with the tools and knowledge to develop and implement comprehensive strategic plans tailored to their business needs working with experienced business development experts/consultants.
- 2. Teach participants how to utilize franchising as a strategy for business growth and expansion.
- 3. Provide global business insights and networking opportunities through international visits, such as a recent learning journey to Strathmore Business School in Nairobi, Kenya, which included a focus on leveraging the African Continental Free Trade Area (AfCFTA).

Corporate Governance Program

To support participants, especially alumni members as well as other emerging corporates within the ecosystem in the process of setting up proper governance and accountability structures to support their next level growth, EDC in partnership with Nigerian Exchange Group (NGX Group), launched a new program on corporate governance. The program exposes participants to the fundamental principles in board formation and strategies on running functional and impactful boards. Participants are also taken on a learning journey to a company that operates a proper board to learn firsthand from the Chairman and members of the board (in a typical meeting session) how they operate while noting the critical elements. Overall, participants receive expert guidance for stronger management, customized board structures and opportunity for certification in Corporate Governance

Thought leadership

EDC has a considerable track in driving conversations and learning and this has played a pivotal role in positioning the centre as a thought-leader in entrepreneurship development in the country. Through carefully thought research collaborations and thought leadership, EDC continues to empower entrepreneurs with the information and tools needed to navigate the changing business landscape.

Roundtables and Share Fairs

EDC is committed to advancing conversations that could help strengthen the entrepreneurship ecosystem in the country. In the period under review, the centre organized a series of roundtable discussions aimed at galvanizing perspectives from stakeholders to issues relating to entrepreneurship.

Six roundtables were held in 4 locations focuing on issues such as finance, inclusive entrepreneurship and access to market. Share Fairs were also organised across the country to help entrepreneurs learn, connect and share experiences.

The events held in 13 locations featured experience sharing sessions by seasoned entrepreneurs and networking opportunities.

Stanbic IBTC SME Program

The Stanbic IBTC SME program, in partnership with EDC, is designed to foster the growth and development of MSMEs by bridging the entrepreneurial skills and knowledge gap, thereby increasing productivity and success rates. The programme components include physical sessions, self-paced online sessions, webinar sessions and one-on-one business advisory sessions. The programme started in 2023 with physical sessions, recording a total of 1,150 participants across various locations, including Ibadan, Abuja, Port-Harcourt, and Awka. Additionally, 1,657 participants engaged in a comprehensive six-month selfpaced online learning programme facilitated through EDC's Learning Management System (LMS).

IFC - LPI Facilitating Face-to-Face Training Programme

The International Finance Corporation's (IFC) Facilitating Face-to-Face (FFF) Training programme for Trainers in partnership with the Learning and Performance Institute (LPI) enables trainers to deliver powerful learning experiences to participants that can help improve capability, capacity, productivity, and performance. 22 Participants have been trained from November 2023 till date.

The programme is aimed at helping participants to conduct engaging, interactive, and informative training sessions and manage the training environment. Furthermore, the participants are exposed to the art of adjusting their teaching style and methods to meet participants' needs. At the end of the training, the participants should be able to facilitate discussions in a way that enhances the learning experience and deepens participants' understanding.

Diversity Equity and Inclusion

In a bid to ensure that no one is left behind in entrepreneurship education and support, EDC has continued to partner with institutions to reach those hitherto unreached. The centre in partnership with Mastercard Foundation under the Transforming Nigerian Youth programme, organized physical training for over 40,000 young females in 24 states of the federation.

For the first time, the centre provided childcare services at the training locations, sign language assistance and delivery of training in four languages. According to Nigeria2Equal: Improving Corporate Competitiveness with Formal Childcare Report, the economic case for the provision of quality childcare and family-friendly workplace policies is compelling and women are more likely to enter and stay in the workforce and learning environment when they have access to quality and affordable childcare options.

Apart from entrepreneurial and business management skills and knowledge, the women are also provided with business advisory services and incentives to help them grow and scale.

I. Global Tech Africa

Providing platforms for entrepreneurs to exhibit and meet potential customers is of utmost priority for EDC. The Global Tech Africa (GTA) event is an initiative that unites key stakeholders from Africa's technology ecosystem to explore the continent's potential for leveraging technology for growth and development.

Considering the recent launch of Nigeria's Start-up Act—a strategic plan to prepare Nigeria for the Fourth Industrial

Revolution—GTA was conceived to capitalize on the opportunities emerging within the tech ecosystem.

The inaugural GTA event is supported by the National Information Technology Development Agency (NITDA) and is designed and implemented by Ascend Studios Foundation. The GTA Summit took place from July 24th to July 26th, 2024. The Enterprise Development Centre (EDC) participated in the three-day event, and two participants from the Women in Tech (WITI) program were given the opportunity to exhibit during the event and connect with stakeholders in the ecosystem.

The mission statement of Pan-Atlantic University (PAU) Press is to advance the research and education objectives of Pan-Atlantic University by publishing peer-reviewed scholarship for its community of students and scholars. Secondarily, PAU Press will advance knowledge production through publications that are at the service and for the enhancement of the local community, Nigeria and Africa.

The vision of PAU Press is to become the flagship of academic knowledge production in the African continent.

Some of the milestones of the Press in 2024 are presented in this report.

Pan-Atlantic University Press to Publish the Journal of Creative Media

Pan-Atlantic University Press (PAU Press) is set to publish the first issue of the Journal of Creative Media (JCM) in August 2024, following a Memorandum of Understanding signed with the Centre for Media and Communication Research (CMCR). The journal aims to bridge the gap in media and communication journals in Sub-Saharan Africa, promoting multidisciplinary research and contributing to policy and sustainable development in Africa.

The move marks a significant expansion for PAU Press, which has previously focused on academic book titles.
